A. <u>Approval of Agreement with the County of Kern for C.A.R.E.S. Act Funds,</u> Resolution #37-20

Finance Director Wayne McArthur requested approval of the agreement with the County of Kern for C.A.R.E.S. Act funds. The county desires to distribute funds to include costs for necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019, costs that were not accounted for in the budget most recently approved by the District and costs that were incurred during the period that begins on March 1, 2020 and ends on December 30, 2020.
