# HOME MEAL DELIVERY DRIVER

To establish a pool of available employees and volunteers, applications are currently being accepted for Home Meal Delivery Drivers to work in the District's Senior Services Department.

### WHAT IS THE HOME MEAL DELIVERY DRIVER

Delivers meals to seniors and disabled individuals who are homebound and cannot come to the lunch program at the Rasmussen Senior Center.

### TASKS PERFORMED BY THE HOME MEAL DELIVERY DRIVER

Assists with packing of home delivery meals, checks the temperature of foods while on delivery route, delivers meals to participants as assigned. Volunteers using a personal vehicle (mileage reimbursed at the current IRS rate) or paid drivers at \$16.50 per hour, can drive a District vehicle. Also, assists with home delivery paperwork, attends staff meetings and other training as recommended by supervisor, and may assist with program related activities when needed.

# LOCATION, HOURS

Weekdays, between 10:00am to 2:00pm, depending on the number of routes assigned, year-round. Delivers meals to participants of the program in the Oildale, Rosedale, and Central areas of Bakersfield.
